A framework for the phased plan for 3 years is emerging:

We have identified four areas: Administration, Field Experiences/Field Station, Courses, and Outputs. How will they grow from year 1 to year 3? In terms of an agreed plan of action:

- Identify primary areas of work: conservation, livelihoods, culture and people, and environmental governance
- Develop semester-long course that precedes trip to field station
- Develop a 3-4 week on-site program at Keystone and surrounding Nilgiri Hills/Western Ghats region
- Plan for assessment and evaluation of program and its products

We must identify a faculty member at Cornell who is familiar with Southern India. Lucinda Ramberg & Andrew Wilford who are anthropologists will be approached if they can bring in some insights. Dan Gold from the South Asia Program mentioned the need to bring in the cultural aspects of south Indian societies.

Service Learning is an important component in the Field Learning Center, discussions on what graduate, undergraduate students would do, how the faculty will be involved in the research. and a cumulative process of knowledge gain and practice sharing will take place. Ideally, in the internationalization of Cornell as an Institution providing world-class global and local opportunities, this idea of the Field Learning Center was ideally suited and an opportunity is seen.
